Nature of the security violation: On June 8, 2015, Ms. Barbie Smith, Secret Clearance, a courier for our facility, did not follow company policy while carrying a classified package (Secret) from our facility to the XYZ Command. Initial information disclosed that Ms. Smith stopped at a residence of another employee (Ken Jones) to have lunch. Apparently, Ms. Smith did not lock her car door(s) and the classified package along with her company computer (unclassified) was stolen out of her vehicle while she was in the home of Mr. Jones. Mr. Jones resides at 1433 Picadilly Street, Norfolk, VA 25318.

This incident was self-reported by Ms. Smith immediately by telephone (12:45pm on 6/8/2015) to the Facility Security Officer (FSO) once she discovered the classified package had been removed from her car. As of this initial report, the package is considered stolen and therefore, the incident appears to be a Loss of Classified Information. This incident appears to be in violation of (NISPOM paragraph 5-410).
